General Rules and Information

1. **Eligibility:** Players **MUST** be at least 15 years old. At least one player **MUST** be a resident of Saline County or a member at one of the three Salina courses.
2. **Cost:** \$180 - if both players are members of at least one course. **\$200 - if one player is not a member of at least one course. (Muni membership minimum of Bronze level)**
3. **Divisions:** There will be 3 divisions: Open, Senior (both players +/- 50), Women
4. **Tees:**
 - Open Division- Blue Tees at all courses
 - Senior - Reds at Muni; Whites at GL & SCC
 - Women's Division – Muni – Yellow Tees, Great Life/SCC – Red Tees
5. Friday round you are responsible for making your own tee time. No tee times after 5:00pm. Pairings will be made for the Saturday round and play will begin between 7:30-8:00AM.
6. Entries are due by April 23rd, 2021 and will be limited to the first 68 teams. Entries may be mailed to SCGA, PO Box 1083, Salina, KS 67402-1083 or emailed to scgagolf@outlook.com. Payment may be mailed or sent via Paypal to scgagolf@outlook.com.
7. Tournament will be flighted after the second round. Winnings may be adjusted based upon the number of teams in each flight.
